 - Sign in front of the street-side fire hydrant (?)
 - Rarely, but may be important
 - o 13-acre park pump repairs
 - Dan/Dale pulled, Rusty testing
 - Backup works
 - Western Skies landscaping confronting about poor work
 - Blowout 10/21
 - o Water leak behind 31 Candlelight update
 - Drain field failing, contractor working on it
 - o Closed headgate willow roots grow into it over the season

 - Not good for their self-sustainance

- Boat needed for pond
 - o [Sue] storage? May have an idea
 - Move the A frames to the shore for winter
- Fire dept. Re: dry hydrant by the pond
 - Phasing them out
 - Ranch pays us maintain our system
 - Backup power won't support the fire flow
 - Would need both wells (requires power)
 - Muck from pond is building up to the opening of the pipe
 - Suction may be needed. Try in the spring for more visibility?
 - Maybe even empty it entirely next spring
 - Drying out the pond for the winter.
 - Would control the weeds through freezing
 - Trash pump in the wellhouse, will achieve it.
 - Planned drain Last week of Oct (weekend?)
 - Maybe deal with the islands during that process
 - Board to continue dialog to plan
